

ORDER

In pursuance of the provisions of Rule 52 of Delhi Excise Rules, 2010, it is hereby ordered that following dates shall be observed as "Dry Day" in the National Capital Territory of Delhi by all L-1, L-1F, L-2, L-3, L-4, L-5, L-6, L-6FG, L-6FE, L-7, L-7FG, L7FE, L-8, L-9, L-10, L-11, L-12, L-12F, L-14, L-18, L-23, L-23F, L-25, L-26, L-31, L-32, L-33, L-34 and L-35 licensees and opium vends located in Delhi.

In addition to above, all L-16, L-17, L-19, L-20, L-21, L-22, L-28, L-29, P-10 and P-13 licensees shall observe dry day on the following day :-

The licensees shall not be entitled to any compensation on account of any changes effected in the above list. The restriction of sale on liquor on dry days mentioned above shall not apply to the service of liquor to residents in case of hotels having L-15 license.


All the licensees shall exhibit this order at some conspicuous place of their licensed premises.

The business premises of a licensee shall be kept closed on dry day.
