CIRCULAR

Sub: Renewal of license of retail vends for the year 2019-2020.

Attention of all the licensees of the retail vends are hereby drawn towards Rule 41, Delhi Excise Rules, 2010, which states as under :


*"All applications for the **renewal of licenses** and permits shall be received in the office of the Deputy Commissioner **before the end of February** along with licenses or permit fee, payable for renewal of licence or permit. In case of delay, the Deputy Commissioner may admit such application before the expiry of the licence or permit, provided that there are good and sufficient reasons for the delay **on payment of additional fee of twenty five percent** of the prescribed licence or permit fee."*

*PROVIDED that the application for renewal of licence or permit may be admitted **after the expiry** of the licence or permit, if there are good and sufficient reasons for the delay on payment **of double the amount of licenses or permit fee** payable, and the licence or permit may be renewed with the approval of the Excise Commissioner."*

1. All holders of licence in form of L-6, L-6F, L-7, L-7F, L-8, L-9, L-10, L-12, L-14, L-22 & L-23 are required to submit their requests for renewal of their licenses for the year ~~2018-19~~ before 28.02.2019. For renewal of license, licensee has to apply in ESCIMS in the following manner:-
 - a. Applicant will click on apply renew for 2019-2020.
 - b. System will display the license details as per login in non-editable form.
 - c. User will provide the details against following non-mandatory fields:
 - (i)Original license start date,(ii)Applicant email address,(iii)Applicant mobile No.
 - d. User will accept the declaration(as per enclosed Proforma), make payment of fee and submit.
 - e. Upon successful realization of fee, the application will be processed by the Department and licensee will get digitally signed license online. Realization of fee is sometime delayed due to involvement of different banks and banking channels. Department shall not be responsible for any failure of payment. Any delay due to delayed payment shall be the sole responsibility of the licensee. Hence, all licensee should ensure timely payment of license fees.
2. The licensee should be in legal possession of the premises, i.e., must possess duly stamped and registered rent/lease deed and ensure that the licensed premises shall be duly insured against fire and natural hazards. The licensee shall keep the premises

(thoroughly clean and dry and shall comply with the orders issued by the Department of Excise for removal of defects in the building.

3. The shop must have air cooling/air conditioning facilities (where ever applicable e.g. L-7, L-9 & L-10) as per the existing Terms & conditions under which the license was granted.
4. Refrigeration facilities for storage of beer shall be mandatory for holders of retail licensees.
5. Installation of CCTV cameras systems having coverage of minimum 50 meters and archival period of 30 days in good working condition, is must.
6. Must be complying with the Terms & conditions on which the license was issued and the provision of Delhi Excise Act & rules made there under.
7. The licensee shall abide by all instructions/orders of the Department relating to operation of L-7 vend, and any other instruction issued by the Department.
8. The Government reserves the right to review the manner of levying license fee and amount of license fee etc. to be paid/payable. In case any of the fees are revised, the same shall be payable and recoverable from the licensees and penalty amount as specified by Competent Authority shall be imposed for depositing amount after the stipulated time period.
9. The Government reserves the right to review the manner of renewal of licenses for retail vend of liquor.
10. All holders of licence in form of L-6, L-6F, L-7, L-7F, L-8, L-9, L-10, L-12, L-14, L-22 & L-23 are required to submit the copy of insurance and affidavit at Annexure-A for renewal of their licenses for the year 2019-2020. All relevant documents will only be uploaded on ESCIMS Portal. No manual receiving of documents will done in this office.







- m). All stock of liquor shall be received & sold through ESCIMS only and stock take shall be performed on regular basis as per guidelines.

6. The first page of renewal letter will display the following line:

I undertake to submit the copy of duly stamped lease deed in support of legal possession of premise for current excise year.

The Government reserves the right to review the manner of renewal of licenses for retail vend of liquor.

The licence shall be liable for cancellation if any document produced/placed on record or any point of declaration undertaken found to be false or forged.

7. Original license start date, Applicant email address, Applicant mobile no. will not be captured for L6/L6FG/L6FE and L8/L14 licenses.

8. Undertaking accepted by licensee at the time of applying renewal will be printed on second page of renewal letter having header.

'The Renewal of License type of license ID has been renewed after accepting following undertaking,':

Given false declaration/information shall liable for cancellation of license and also panel action against the existing licensee.
