CIRCULAR



It is hereby directed that all the HCR Licensees shall fix the Display Board for awareness regarding " Consumption & Trafficking of Narcotic Drugs & Psychotropic Substances is Prohibited in Law and Punishable with Rigorous Imprisonment and Fine" as per the enclosed format.

In this regard all the HCR Licencees are directed to display the Board at the 02 main conspicuous places and submit the compliance report of the same with documentary evidence to this branch within 10 days of receipt of the order.

Non-compliance of the said circular will be viewed seriously. In any case, if the above display board is not found fixed by the Inspecting Team of the Department, necessary action will be initiated against the errant HCR licensee, as per the rules.
