NOTIFICATION

No.F.12(4)/Fin(Rev-I)/15-16/587 :- In exercise of the powers conferred by sub-section (1) of section 81 of the Delhi Excise Act, 2009 (Delhi Act 10 of 2010), the Government of National Capital Territory of Delhi hereby makes the following rules to further amend the Delhi Excise Rules, 2010, namely :-

- (1) **Short Title and Commencement :** (i) These rules may be called the Delhi Excise (Amendment) Rules, 2015.
(ii) They shall come into force on the date of their publication in the Delhi Gazette.
2. **Amendment in rule 154 – In the Delhi Excise Rules, 2010, in rule 154, -**
 - (i) in sub-rule(1), in clause (b), for the words and figure "Rs. 5 lacs" the words and figure "Rs. 7.5 lacs" shall be substituted.
 - (ii) in sub-rule(2), in the table relating to Licence Fees for Other Category of Licences -
 - (a) in column No.5 at S.No. 4, for figure "2,50,000" the figure "4,00,000" shall be substituted.
 - (b) in column No.5 at S.No. 17, for the existing entries, the following entries shall be substituted, namely:-
