CIRCULAR

Subject: Renewal of L-15/L-15F and L-16/L-16F Licenses for the Licensing Year 2016-17.

All the Licensee (s) holding license in form L-15/L-15F and L-16/L-16F are hereby directed to submit the following information/documents online (ESCIMS portal) along with applicable License Renewal Fee, for renewal of respective licenses for the Year 2016-17 latest by 29.02.2016 without fail.

- i. Undertaking/Affidavit as per Annexure-I
- ii. Application for license renewal alongwith licence fee as mentioned below:

The Govt. of NCT of Delhi vide Notification No. F.12(4)/Fin(Rev-1)/15-16/ds-VI/587 dated: 22.07.2015 has made amendments in Column 5 of Sl. No.17, 19 of sub rule (2) of Rule 154 under the Delhi Excise Rules, 2010 which is reproduced below:

The Motel already classified by, Govt. of India, Ministry of Tourism, shall pay license fee on the basis of that classification until their re-classification.

24X7 SCHEME

All the Five Star & Above Category hotels who have already taken permission for opening one or more L-16/L-16F unit, round the clock (24X7) have to apply for the permission afresh for the next Licensing Year. The scheme is open to all the Hotels classified under Five Star and above Five Star Category.

License fee for 24x7

For: - Motel (Delux) Rs.20,00,000/-

Up to 5 star category Rs 30,00,000/- and

Above 5 star (5 star Dx.) category Rs. 40,00,000/-

The above mentioned License fee for L-15/L-15F and L-16/L-16F licenses are the same as applicable as on date, the Department reserved the right to review the license fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit or take other suitable action.

Further Vide Notification F.10(3)//fin(Rev-1)/2013-14 dated 06.08.2013 the following amendment in Rule 41 has been done.

“3 Amendment of rule41:-In the Delhi Excise Rules, 2010for rule 41, the following shall be substituted namely:-

“All applications....

“Provided.....

Provided further that in case of license in form L-15/L-15F, L-16/L-16F, L-17/L-17/f and L-18/L-18F and L-18A/L-18F, the license fee is payable in two equal installments **after completion of all documentary requirements**. First installment of 50% of the license fee should be paid before end of February each year failing which additional fee of 25% of 1st installment shall be payable till 31st March and beyond that double the amount of 1st installment shall be payable, Second Installment of remaining balance amount of license fees should be paid before 30th September each year alongwith interest @12% per annum failing which double the amount of 2nd installment shall be payable.”

Besides above, the existing licencees are also directed to submit online the detailed information/documents, as per annexure-II, for the purpose of preparation of data base for Hotel.

However, it is clarified that onus of obtaining the linked license from concerned Deptt remains with the licensee. In case any of the linked license/NOC is withdrawn/cancelled/terminated, the Excise license shall also be liable for cancellation/termination without prejudice to action as per provisions of Delhi Excise Act 2009, rules framed there under and administrative instructions issued from time to time.

It is also clarified that cases will be considered for renewal only when complete fees is received along with undertaking in the prescribed format (Annexure-I).

All applications for renewal with license fee must be submitted online latest by 29/02/2016, failing which penal action as provided in Rule 41 of Delhi Excise Rules, shall be taken. The licensee should submit renewal application with fee by due date accessing their account in ESCIMS portal through their I.D. and password.

It may be noted that failure to adhere to the above schedule for applying for renewal of licences may also lead to Non-renewal of licences/suspension of issuance of transport permits.



The license fee is as per the current order and any upward revision in fees could be reviewed and the Licensee shall be liable to pay the difference in fee from the date of such notification.

The Department reserves the right to review the terms and conditions of renewal of licenses and any change in this regard shall be binding on the licensees.
