ORDER

Whereas, vide this office circular No. 2(98)/Ex/HCR/2020-21/1991 dated 31.01.2020 and 2(98)/Ex/HCR/2020-21/1992 dated 31.01.2020 all the L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F licensees were directed to pay the licence fee for renewal of excise licence in accordance with Rule 41 of the Delhi Excise Rules, 2010.


And whereas, Rule 41 of the Delhi Excise Rules, 2010 provide the options to all the L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F licensees to pay the licence fee in two equal installments, the 2nd Installment of license fee alongwith 12% interest is due to be paid before 30.09.2020.

And whereas, Delhi is threatened with the spread of COVID-19 epidemic, which has already been declared as a pandemic by the World Health Organization.

And whereas, considering the requests for sympathetic view in regards to appropriation/ adjustment of liquor licence fee due to Covid – 19 Pandemic, the competent authority, in view of the provisions of Rule 49 of the Delhi Excise Rules, 2010, has decided that *"the lockdown period due to COVID 19 from the date of lockdown and till the opening of the licensed premises by the Delhi Government orders to be treated as deemed cancellation of licence and accordingly, the licence fee paid in advance by the licensees shall be adjusted for the corresponding future period payable for the half year beginning 1st October, 2020"*.



Accordingly, the licensees holding excise licence in form of L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F, are directed to pay second Installment of remaining balance amount of license fees (after adjustment) as per annexure attached before 30th September 2020, i.e. by the midnight of 29.09.2020 failing which double the amount of 2nd installment shall be payable.


