PROVIDED that the application for renewal of licence or permits may be admitted after the expiry of the licence or permit, if there are good and sufficient reasons for the delay on payment of double the amount of licence or permit fee payable, and the licence or permit may be renewed with the

Further vide Notification F.10(3)/Fin(Rev-I)/2013-14 dated 6.8.2013 the following amendment in Rule 41 has been done.

Amendment of rule 41.- In the Delhi Excise Rules, 2010 for rule 41, the following shall be substituted, namely:-

...Provided further that in case of licence in form L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F and L-18A/L-18AF, the licence fee is payable in two equal installments after completion of all documentary requirements. First installment of 50% of the licence fee should be paid before end of February each year, failing which additional fee of 25% of 1st installment shall be payable till 31st March and beyond that double the amount of 1st installment shall be payable. Second Installment of remaining balance amount of licence fees should be paid before 30th September each year alongwith interest @ 12% per annum failing which double the amount of 2nd installment shall be payable."

The Department reserves the right to review the nature of renewal of licences and any change in this regard shall be binding on the licencees.
