





The above mentioned L-7/L-9 shops are allowed to open/resume sale subject to following conditions:

1. They are allowed to open w.e.f. 23.05.2020 on alternate days between 9:00 am to 6:30 pm, irrespective of their shops having both odd and even numbers.



2. They shall deposit 70% Special Corona Fee on total sales daily, which will be deducted from their ledger account linked with their Vend-ID in ESCIMS. They should therefore, maintain the requisite balance in their ledger account.
3. They must strictly comply with the National Directives for COVID-19 Management (Annexure-II of MHA's order dated 17.05.2020). They are further directed to take all possible measures including deployment of adequate number of guards, proper barricading, marking to ensure social distancing, etc. in coordination with Delhi Police and local administration.
4. In case of any un-scanned sale, the MSR Gap generated shall be treated as the stock sold and 70% Special Corona Fee shall be levied / payable on the same.
5. In case any L-7/L-9 licensee/shop allowed to operate comes under the Containment zone in future, the same shall be closed immediately.
6. Further, in case any L-7/L-9 shop allowed to open on the basis of any false information/undertaking furnished by the licensee, action shall be taken under Delhi Excise Act, 2009 and rules made thereunder.


