PUBLIC NOTICE

Government of National Capital Territory of Delhi has decided to grant license in form of L-1 for wholesale supply of Indian Liquor and Foreign Liquor in the National Capital Territory of Delhi for the licensing year 2021-22.

The prescribed form for the grant of L-1 Licenses can be obtained from the website <http://excise.delhigov.nic.in> under heading "Latest News". A processing fee of Rs.5000 (Rupees Five Thousand only) for L-1 license shall have to be deposited along with the application form by the way of online payment in favor of Deputy Commissioner (Excise), Delhi. Applicants are required to apply online for grant of L-1 licenses at delhiexcise.gov.in.

The terms and conditions for the wholesale license L-1 for the year 2021-22 have already been uploaded on the website. The same has been partially modified vide Addendum dated 29.07.2021, which is annexed herewith. The same can be downloaded from the department's website <https://delhiexcise.gov.in/Communications.htm>

The Government reserves the right for a review of manner of levying duties/fees and amount of duties/fees etc. to be paid / payable, in case any amendment is made to the Act, Rule or Law related to liquor and Bonded Warehouse in Delhi during the period of license. Accordingly, the changes if any shall be binding to all the L-1 licensees.

The L-1 licensees can supply/distribute only to the new retail licensees i.e. L-7Z/L-7V/L-7SP1. Further, the date of commencement of operation of wholesale license (L-1) shall be same as of the date of commencement of retail licensees i.e. L-7Z/L-7V. The L-1 licensee will not claim any right for starting operation before this.

Application received without complete information and supporting documents, as required in prescribed form, along with its annexure shall be liable to be rejected.

ADDENDUM

This addendum supplements the clause 3.1 of the terms and conditions for grant of L-1 license for the year 2021-22 already uploaded and available at [https://delhiexcise.gov.in/pdf/Terms and Conditions for Grant of L-1License for year 2021-22.pdf](https://delhiexcise.gov.in/pdf/Terms%20and%20Conditions%20for%20Grant%20of%20L-1License%20for%20year%202021-22.pdf), with the following:

"However, considering the number of operative months left to run wholesale operations in financial year 2021-22, the License fee for wholesale license in form L-1 shall be levied on pro-rata basis for 6 months in financial year 2021-22 i.e. October, 2021 to March, 2022. However, if any applicant applies for wholesale license in form L-1 after 01.10.2021 then, he shall be liable to pay the license fee for entire 06 months, as aforesaid, and the period of calculating the pro-rata license fee shall not be calculated from the date of receipt of application"
