In case of delay in applying for renewal in prescribed application form along with requisite documents up to 31st March 2015, application for renewal shall be admitted on payment of additional the amount of 25 % of the license fee and sufficient reason for delay in writing with the approval of Dy.Commissioner (Excise) before the expiry of the license. After the expiry of the license i.e. 31st March, application for renewal shall be admitted on payment of double the amount of the license fee and sufficient reason for delay in writing with the approval of Commissioner (Excise) Only:-

The licensee should submit the required fee and renewal application by the due date accessing their account in ESCIMS portal through their USER ID and password. A hard copy of print out of the application may be submitted in this office alongwith copy of Challan.

The License fee is as per the current order and any upward revision in fee could be reviewed and the license shall be liable to pay the difference in fee from the date of such notification.

It may be noted that failure to adhere to the above schedule for applying for renewal of licenses may also lead to Non-renewal of licenses/Suspension of issuance of transport permits.
