CIRCULAR

Subject: Renewal of License in form of L-15/L-15F and L-16/L-16F for the year 2021-22.

Whereas, the Excise Retail licenses for consumption "on" the premises have been granted by the Government for operating in jurisdiction of NCT of Delhi in the form of L-15/L-15F and L-16/L-16F.

And whereas, the Government of NCT of Delhi is currently in the process of framing revised Excise Policy which will comprehensively address all issues currently being faced with regard to the sale of liquor in the National Capital Territory of Delhi.

And whereas, the framing of the said policy is at an advanced stage based upon comments provided by stakeholders/general public.

And whereas, pending finalization of the new Excise Policy, it has been decided by the Competent Authority to renew all existing L-15/L-15F and L-16/L-16F for a period of 3 months from 01.04.2021 to 30.06.2021 on payment of proportionate license fee ON OR BEFORE **28.03.2021** for the said period of 3 months subject to the following conditions:

- 1. All the licensees of L-15/L-15F and L-16/L-16F, are hereby directed to submit their application for renewal of license online by accessing their account in ESCIMS portal through their I.D. and password along with the applicable license renewal fee for the period of 3 months by providing the requisite information and payment of renewal license fee on or before 28.03.2021.
- 2. After due submission of application, the Licencee should accept the declaration as per enclosed Performa.
- 3. The Licensee should ensure that the licenced premises remains in his legal possession during the currency of licence as required under section 13 (1) (f) of the Delhi Excise Act, 2009.
- 4. The license fee has been increased by 10% from the last year license fee in compliance to the Notification No. F.12(4)/Fin(Rev-I)/15-16/dsvi/587 dated 22.07.2015 issued by Finance Department, GNCT of Delhi and accordingly the revised license fee for the period 01.04.2021 to 30.06.2021 will be adjusted and levied on proportionate basis for the period of 3 months on the fee structure with an increase of 10% per annum as per the fee structure described as follows:

The Motel already classified by, Govt. of India, Ministry of Tourism, shall pay license fee on the basis of that classification until their reclassification.

24X7 SCHEME:

The Govt. of Delhi vide Notification No.F.12 (1)/Fin.(Rev.-1/2017-18/DS-VI/824 dated 20.12.2017 has made amendments in Rule 154 under the Delhi Excise Rules, 2010 which is reproduced as below:

At. S. No. 19, in the end of the table for entries,

*Fee for service of liquor round the clock:

- (i) 5 Star Rs 30,00,000/-
- (ii) 5 Star Deluxe and above- Rs.40,00,000/-
- (iii) Motels (Deluxe)-Rs.20,00,000/-"

The following shall be substituted, namely:-

5. "Fee for service of liquor round the clock for 4 Star hotels, 5 Star hotels, 5 Star Deluxe and above category hotels and Motels (Deluxe) shall be additional 50% of the basic annual licence fee of that particular restaurant"

All the Five Star & above Category hotels who have already taken permission for opening one or more L-16/L-16F unit, round the clock (24X7) have to apply for the permission afresh for the next Licensing Year. The scheme is open to all the Hotels classified under Four Star, Five Star and Five Star Deluxe and above Category.

Contd-4/-

The above mentioned License fee for L-15/15F and L-16/16F licenses are the same as applicable as on date, the Department reserves the right to review the license fee and in case the same is increased, the licensee shall be liable to pay the increased amount within the stipulated time period failing which the Department shall have the right to stop the transport permit of the unit or take any other suitable action.

It is further to inform that there will be no workflow for approval of Hotel Renewal ARN. After the payment is successful, the status of the Renewal ARN will change to "Deemed Renewed".

- The following message will be shown to Hotel Licensee post successful payment of Renewal fee -
 - "Your License has been deemed renewed for the Excise Year <Excise Year Value>, subject to verification of Additional Details as per Department's Requirement. Please fill and complete the 'Provide Additional Details' form by going to the following link: License → Provide Additional Details."
- Also post successful payment of Renewal Fee, Hotel Licensee will be able to download the deemed Renewed License copy by going to the following link: License → Print Letters.

Besides above, the existing licensees are required to fill and complete the 'Provide Additional Details' form by going to the following link: License \rightarrow Provide Additional Details."

Only the following documents will be mandatory to uploaded by Hotel Licensees in 'Provide Additional Details' in addition to affidavit form which will have to be filled and completed by the Hotel Licensees as part of the 'Provide Additional Details' functionality by 30th April 2020:

- 1. Copy of Insurance against Fire & Natural Hazard.
- 2. Fire NOC (mandatory for the licensees holding L17/17F, L18/18F & L19/19F with gross floor area of more than 90 sqmtrs. as per clarification given by Chief Fire Officer vide letter dated 13.03.2019).
- 3. In addition to above noted two documents, the application under ARN 'provide additional details' can only be submitted on ESCIMS portal once the licensee uploaded copies of licences issued by link departments for previous financial year, e.g. if the licensee is applying for renewal of excise licence for the year 2021-2022, he should upload copy of licenses issued by link department (viz. copy of Health & Trade, Eating House License from DCP (L), copy of FSSAI license, copy of Lodging House Certificate from Police Authority) for the year 2020-21 alongwith copy of renewal application submitted in concerned department for the year 2021-2022. Although this ARN of 'provide additional details' shall have no effect on renewal of licence, but transport permit (TP) of the licensees shall be made subject to submission of said ARN of 'provide additional details' the date of which has been fixed for 30th April 2021.

In case Licensee, who has made renewal payment successfully, does not submit 'Provide Additional Details' application by 30th April 2021, a batch process will run on 30th April 2021 at 11:30pm, which will check and mark the licensee status as STOP TP.

To activate the license:

- For Licensee's who have made renewal payment successfully- Such licensees will have to login and apply for provide additional details. When the provide additional details application gets approved by Dept in system, it's License gets enabled.
- For Licensee's who have not made renewal payment Such licensees will have to make License Renewal payment first and then apply for provide additional details. When the provide additional details application gets approved by Dept in system, it's License gets enabled.

All applications for renewal with license fee must be submitted online ON OR BEFORE 28TH MARCH 2021. The licensee should submit renewal application with fee by due date accessing their account in ESCIMS portal through their I.D. and password alongwith the acceptance of Declaration as per enclosed Performa.

This issues with the prior approval of the Competent Authority.

PROFORMA

The licensee shall have to give declaration in the attached proforma:-

- 1.Declaration will include following points:
 - a. All the Directors/Partners/Proprietors of the company/firm are citizens of India.
 - b. None of the Directors/Partners/Proprietors of the company/firm have been disqualified under Section 13 of Delhi Excise Act, 2009.
 - c. There are no criminal antecedents or cases pending against any of the Directors/Partners/Proprietors of the company/firm in any Court of Law.
 - d. The company/firm has no government dues.
 - e. The business premises have not been constructed in violation of any law and I/we are legally in possession of the same.
 - f. The Directors/Partners/Proprietors of the company/firm do not indulge in any other business from same premises other than liquor for which license is being granted.
 - g. The Directors/Partners/Proprietors of the company/firm do not possess any wholesale license or any other retail license of liquor.
 - h. The Company/firm has applied for renewal of licenses with FSSAI/MCD/NDMC/Delhi Police/Delhi Fire Service and these have not been cancelled by any of the concerned authority.
 - i. The licensed premises is duly insured against fire and natural hazard.
 - j. Installation of CCTV cameras systems having coverage of minimum 50 meters and archival period of 30 days in good working condition.
 - k. There is no change in constitution of company/firm. The Directors/Partners/ Proprietor of the company is same.
 - I. The Company/firm is registered with DVAT and Income Tax Department and the due returns have been filed with the concerned authority.

- m. The Directors/Partners/Proprietors of the company/firm shall abide by all instructions/orders issued by the Excise Department time to time.
- n. All stock of liquor shall be received and sold through ESCIMS only and stock take shall be performed on regular basis as per guidelines.
- o. I will abide by the terms and conditions of the new policy to be decided by the Government for 2021-22.
- p. Further, I am fully aware that my license validity is only for three months i.e. w.e.f. 01.04.2021 to 30.06.2021 and the Government reserves the right to decide the period for which my license has been granted. The Government shall not be under any obligation whatsoever to continue my license beyond expiry i.e. 30.06.2021.
- q. The Government reserves the right to review the manner of levying licenses fee and amount of license fee etc. to be paid/payable. In case, any of the fees are revised the same shall be payable and recoverable from the licensees and penalty amount as specified by Competent Authority shall be imposed for depositing amount after the stipulated time period.
- r. This is subject to the fact that if any of the linked licences/permissions are cancelled, the excise licence will be deemed cancelled.

I certify that particulars stated above are correct to the best of my knowledge and non-material facts to be concealed. (Checkbox declaration)

- 2. Applicant will not be allowed to submit the renewal application without accepting the declaration.
- 3. A confirmation alert will be occurred at time of submitting renewal application stating that "Do you want to proceed"?
- 4. Original License start date cannot be current date and future date.
- 5. A following note on renewal screen will be displayed:

"In case of any change in the Directors/Partners/Proprietors, information shall be updated in the ESCIMS prior filling of renewal".

The license shall be liable for cancellation if any document produced/placed on record or any point of declaration undertaken found to be false or forged.

8. Undertaking accepted by licensee at the time of applying renewal will be printed on second page of renewal letter for the period <u>01.04.2021 to 30.06.2021</u> having header.

Note:

Given false declaration/information shall liable for cancellation of license and also panel action against the existing licensee.
