CIRCULAR

Subject: Renewal of License in form of L-17/L-17F, L-18/L-18F and L-19/L-19F for the year 2017-18.

All the licensees holding licenses in form of L-17/L-17F, L-18/L-18F and L-19/L-19F are hereby directed to submit following information/documents online accessing their account in ESCIMS portal through their I.D. and password along with the applicable license renewal fee for the year 2017-18 latest by 28.02.2017 without fail.

- 1. Application for license renewal.
- 2. Undertaking/Affidavit as per Annexure-I
- 3. Valid NOC from Delhi Fire Service that licensed premises is safe from fire point of view by the restaurant running with above 50 seat covers. In case the restaurant is running with less than 50 seat covers then an undertaking regarding taking all the safety measure in case of fire should be given by the licensees.
- 4. Copy of valid Insurance against any fire hazard.
- 5. Copies of other licenses issued by the link departments for the year 2016-17.
- 6. The license fee which has been increased by 10% from the last year license fee in compliance to the Notification No. F.12(4)/Fin(Rev-I)/15-16/dsvi/587 dated 22.07.2015 issued by Finance Department, GNCT of Delhi and accordingly the revised license fee for the year 2017-18 will be as under:

Further vide Notification F.10 (3)//fin(Rev-I)/2013-14 dated 06.08.2013 the following amendment in Rule 41 has been done.

"3 Amendment of rule 41:- In the Delhi Excise Rules, 2010 for rule 41, the following shall be substituted namely.

"All Applications.....

"Provided.....

Provided further that in case of license in form L-15/L-15F, L-16/L-16F, L-17/L-17F and L-18/L-18F and L-18A/L-18F, the license fee is payable in two installment after completion of all documentary requirements. First installment of 50% of the license fee should be paid before end of February each year failing which additional fee of 25% of 1st installment shall be payable till 31st March and beyond that double the amount of 1st Installment shall be payable, Second Installment of remaining balance amount of license fees should be paid before 30th September each year alongwith interest @12% per annum failing which double the amount of 2nd installment shall payable."

Besides above, the existing licensees are also directed to submit online through ESCIMS the detailed information/documents/Licenses issued by the link through departments for the year 2017-18 before 30.04.2017 for the purpose of preparation of data base for Restaurants.

Licensee shall upload the valid Fire NOC and Insurance on or before

In case the licensee fails to submit renewed documents online by accessing 28.02.2017. their account in ESCIMS portal through their I.D. and password or any of the linked license withdrawn/cancelled/terminated during the validity of excise license, the Excise license shall also be liable for cancellation/termination without prejudice to action as per provisions of Delhi Excise Act, 2009, rules framed there under and administrative instructions issued from time to time.

It is also clarified that cases will be considered for renewal only when complete fees is received along with the documents noted above through online/ESCIMS. Onus of obtaining the linked license from concerned Deptt. remains with the licensee. The department reserves the right to review the terms and conditions of license renewal & fee. In case the same is increased, the licensee shall be liable to pay increased amount within the stipulated time period, failing which suitable action including stopping of transport permit shall be taken.

All applications for renewal with license fee must be submitted online latest by 28.02.2017, failing which penal action as provided in Rule 41 of Delhi Excise Rules, 2010, shall be taken. The licensee should submit renewal application with fee by due date accessing their account in ESCIMS portal through their I.D. and password.

All the Licensees are further directed that before applying for renewal of license they must ensure that location of their licensed premises is not in violation of Hon'ble Supreme Court Judgment dated 15.12.2016 in civil appeal No. 12164-12166 of 2016(Arising out of SLP (C) No. 14911-14913 of 2013(Ref. writ petition No. 23773 of 2012 and MP Nos. 9 & 10 of 2013). The State of Tamil Nadu Rep by its Secretary Home, Prohibition & Excise Department & ors. Vs. K. Balu & Anr. With civil appeal No. 12169 of 2016 & Civil Appeal No. 12170 of 2016.

It may be noted that failure to adhere to the above schedule for applying for renewal of licenses may also lead to Non-renewal of licenses/suspension of issuance of transport permit.

This issues with prior approval of competent authority.
