<u>ORDER</u>

Subject: Levy of Special Corona Fee @ 70% of the Maximum Retail Price (MRP) on all types of liquor from the consumer at the point of sale by the retail licensee, reimbursable to the Government.

The Government of NCT of Delhi vide Notification No.F.3(2)/Fin.(Rev-I)/2020-21/DS-VI/150 dated 04/05/2020 has levied a Special Corona Fee @ 70% of the Maximum Retail Price (MRP) on all categories of liquor from the consumer at the Point of Sale by the retail vend licensees for consumption "off" the premises, which will be further reimbursed to the Government.

Therefore, you are hereby directed to collect the Special Corona Fee @ 70% of the Maximum Retail Price (MRP) on all categories of liquor sold in NCT of Delhi though your retail vends with immediate effect. Further, the daily sale shall be compiled vend-wise by each licensee and a consolidated statement be submitted to this Department on a daily basis. The collected Special Corona Fee shall be reimbursed to the Government on a weekly basis.

A copy of this order should be **prominently displayed** by the licensees at every vend before starting any liquor sale w.e.f. 05/05/2020.
