ORDER

Whereas vide this office circular No 2(111)/EX/HCR/2021-22/46, 2(111)/EX/HCR/2021-22/47 and 2(111)/EX/HCR/2021-22/48 dated 11.06.2021 all the L-15/L-15F, L-16/L-16F L-17/L-17F, L-18/L-18F, L-19/L-19F, L-28/L-28F and L-29/L-29F licensees were directed to pay the licence fee for extension/renewal of Excise Licence for the period 01.07.2021 to 30.09.2021.

And whereas, due to COVID-19 pandemic, there was a Lock Down in NCT of Delhi and as per the orders issued by Delhi Disaster Management Authority (DDMA) all the Bars in Restaurants, Hotels, Clubs were closed w.e.f.16.04.2021 to 20.06.2021.

And whereas, considering the impact of COVID-19 and the lockdown on Hotels and Restaurants in Delhi, the Competent Authority in view of the provisions of Rule 49 of the Delhi Excise Rules 2010 has decided that the lockdown period (i.e.16.04.2021 to 20.06.2021) may be treated as deemed cancellation of licences and accordingly, the licence fee paid by the licensees for the first quarter of 2021-22 may accordingly be adjusted towards license fees of the second quarter i.e. 01.07.2021 to 30.09.2021.

Further, the Competent Authority has also decided that the last date of payment of license fee of second quarter be extended from 30.06.2021 to 31.07.2021.

Accordingly, the licensees holding Excise License in form of L-15/L-15F, L-16/L-16F L-17/L-17F, L-18/L-18F, L-19/L-19F, L-28/L-28F and L-29/L-29F are directed to pay the remaining balance amount of license fee of second quarter (after adjustment) as per Annexure enclosed upto 31.07.2021, failing which double the amount of quarterly fee shall be payable.
